SUMMARY OF THE PROCEEDINGS OF POSTAL BALLOT OF GRAPHITE INDIA LIMITED HELD THROUGH REMOTE E-VOTING CONCLUDED ON MARCH 24, 2026

The Board of Directors vide their resolution dated February 9, 2026, approved the postal ballot notice entailing the following resolutions to be considered and approved by shareholders through remote e-voting pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014

- a) The Company had engaged the services of **MUFG Intime India Private Limited** ('MI IPL') for the purpose of providing e-voting facility and technical services relating to the Postal Ballot to all its members.
- b) The Board had appointed Mrs. Swati Bajaj, Partner Bajaj Todi & Associates, Practicing Company Secretaries, Kolkata (CP No.3502) as the Scrutinizer for conducting the e-voting process in a fair and transparent manner.
- c) In accordance with applicable MCA and SEBI circulars, the postal ballot notice was sent through electronic mode to those members whose e-mail addresses were registered with the Company/ Depositories and whose names are recorded in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date February 13, 2026, seeking approval as set out in the postal ballot notice.
- d) The total number of shareholders as on the cut-off date was 205392.
- e) Pursuant to the above, the postal ballot notice was sent to all eligible shareholders, electronically, on February 19, 2026.
- f) A Public advertisement was published on February 20, 2026, in Business Standard in English and Aajkaal in Bengali.
- g) The e-voting commenced on 23rd February, 2026 (9.00 AM IST) and closed on 24th March, 2026 (5.00 PM IST).
- h) The Scrutinizer unblocked the votes casted under e-voting and downloaded the details after completion of e-voting period from MI IPL portal in the presence of two witnesses. The Scrutinizer then rendered her report to the Chairman.
- i) The Chairman took the report on record and declared that the resolutions set out in the postal ballot notice dated 18th February, 2026 were passed with requisite majority.
